 - ii) Provision of an assessment report by a chemicals notification and assessment scheme operating under the OECD (other than Canada); or
 - iii) Provision of an assessment report by TGA, APVMA and FSANZ; or
 - iv) The chemical is similar to a chemical which has been previously assessed by NICNAS

- d) Modular – Secondary Chemical fee is applicable if the chemical is being notified at the same time as a similar chemical (primary chemical) and for a similar use.

The entry fee may not represent the final fee. The appropriate fee will be advised following screening of the application.
